






Brief Organizational History

In 2000, the Substance Abuse and Mental Health Services Administration (SAMHSA) convened Hispanic leaders from across the country at the Hispanic Mental Hispanic Congress that produced a major National Action Plan to address the mental health needs of Hispanics in the United States. The plan called for the creation of national organization for Hispanic mental health and a national Hispanic consumer organization to coordinate and target education and advocacy around mental health and mental illness. In March 2001, the National Latino Behavioral Health Association (NLBHA) was formed as a non-profit organization.

Today NLBHA manages both the National Hispanic and Latino Prevention Technology Transfer Center and the National Hispanic and Latino Addictions Technology Center. 


NLBHA's Vision and Mission






NLBHA Policy Priorities

- 5. Latino Family Focused Interventions






Purpose


The purpose of the 2019 SAMHSA, National Hispanic/Latino Prevention Technology Transfer Center's, National Needs Assessment Query is to aid in determining the prevention workforce needs for serving Hispanic/Latinos, and to demonstrate national prevention priorities for serving the Hispanic/Latino population from the perspective of high need sub populations, as well as Training and Technical Assistance needs on prevention.




The Development of the National Hispanic/Latino Prevention Needs Assessment Query

Development Steps of the Needs Assessment Query

- **Step 1:** Analysis of the available literature, data obtained from group meetings, interviews, and reviews.
- **Step 2:** A range of items based on step one were developed into questionnaire format.
- **Step 3:** The pilot questionnaire was administered to a variety of staff/professionals; their responses allowed refinement of the instrument into its final format.
- **Step 4:** The Query was launched online in Both English & Spanish during the month of February through the first week of March 2019. Over 4000 total email requests were sent.
- **Step 5:** The total number of (English & Spanish) completed queries in February was 308, and the total number of (English & Spanish) completed queries the first week of March was 81.
- **Step 6:** A grand total of 389 completed Query's were returned (over 9% response rate).




Demographics



Options ranged from "very interested" to "not at all interested"






Results Summary

The NHLPTTC Query allowed for a total of 389 participants to participate in shaping the Prevention Training & Technical Assistance services offered to a variety of individuals and organizations.

In Summary, the NHLPTTC Query:


- Represents one of the first National polls/queries of Substance Use Disorder(SUD) Prevention needs.
- Both Hispanic and Non-Hispanics participated in the online Query.
- Most respondents were from the Southwest and Western SAMHSA Regions.
- Clearly, cultural issues and topics that impact SUD are high priority areas of training needs, including topics such as Cultural Competence and Acculturation Stress.
- Capacity Building Needs identified are related to Cultural Diversity & Enhancing Cultural Competence (e.g. CLAS Standards, Language Access).
- Additional Queries in the future may reflect changing contextual and policy issues facing Hispanic/Latinos.


